The region has paid the entry fee for Paul Schneider for his entry last year at the nationals as provided in the PNW Rules.

Rose City will host the Regional Helper/Tracking Seminar Denis Krigbaum moved. Jeff Theis seconded. Motion passed unanimously

Having the Regional Event in September is becoming an extreme hardship for clubs due to the difficulty in procuring suitable tracking. After much discussion the group concluded that the Regional will be held sometime between April and October of each year. The hosting club would get the date secured ASAP upon bidding for the event.

As this motion results in a change to the PNW region's By-Laws it was determined that the change to the By-Laws would be voted on within the next two weeks via group phone or a zoom call. Pat Driscoll, member at large, will co-ordinate this call.
